

AUTHORIZATION FOR SCATTERING OR PLACEMENT

I/We , the undersigned, hereby authorize FLORIDA FUNERAL HOME & CREMATORY, (hereinafter referred to as the "Company") to take possession of, and make arrangements for, the disposition of the cremated remains of _____(Name of Deceased), (hereinafter referred to as the "Deceased") in accordance with and subject to: the terms and conditions set forth in this Authorization; the Company's rules and Regulations; and any applicable federal, State or local laws and regulations.

If no specific instructions are provided herein, scattering or placement will be performed by the Company or its agents at the discretion and convenience of the company.

Scattering consists of either the disbursement of cremated remains at sea or in a defined area within a dedicated cemetery beneath the surface of the ground. Placement consists of depositing of the cremated remains in a receptacle or interment space within a dedicated cemetery, as set forth by local, state and federal laws.

I/We acknowledge that when scattering or placement is to be performed in a common garden, area, or receptacle, particles of cremated remains of the Deceased are commingled with particles of other cremated remains. I/We acknowledge that once the cremated remains of the Deceased are scattered or placed, they are unrecoverable.

Unless otherwise specifically provided for herein, once scattering or placement of the cremated remains of the Deceased has been performed, the Company reserves the right, at its sole discretion, to dispose of the container which contained said cremated remains.

The obligation of the Company shall be limited to the disposition of the cremated remains of the Deceased as directed herein. I/We agree to release and hold the Company, its affiliates and their agents, employees, successors and assigns, harmless from any and all loss, damages, liability or causes of action (including attorneys' fees and expenses of litigation) in connection with the disposition of the cremated remains of the Deceased as authorized herein or with respect to the identification of said cremated remains as being those of the Deceased.
